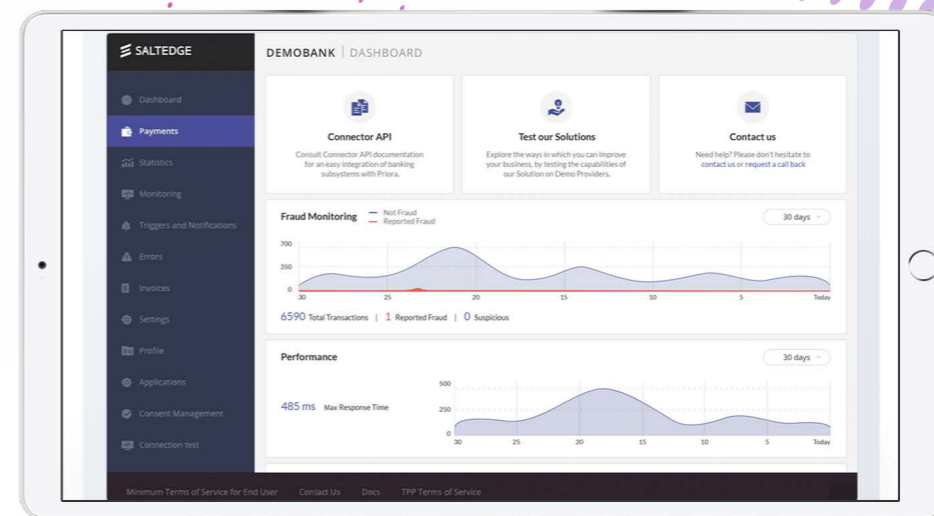

The Open Banking Compliance solution offers Payment Services Directive (PSD2) and Open Banking Compliance SaaS, connector API, Third Party Provider (TPP) developer portal and bespoke dashboards.

Open Banking Compliance is a cloud-based tool enabling the authorized TPPs to access Account Information Service Provider, Payment Initiation Service Provider, and Payment Instrument Issuer Service Providers. It can oversee the entire TPP's verification process. As a part of the solution, consent history and statuses are being transparently shared between TPP and Account Servicing Payment Service Provider (ASPSP). ASPSP has access to an end-point that can be presented within one of the ASPSP's interfaces allowing easy consent management at any time.

Connector API is a tool pre-integrated with Finastra's Fusion Essence and Fusion Equation for fast TPP onboarding. This ensures easy deployment for any bank in the European Union, United Kingdom, Australia, Brazil, Saudi Arabia, and other regions adopting an open banking regulatory framework. Salt Edge takes care of all the required components, ensuring minimal tech integration and support from the bank's side. The TPP developer portal includes a set of services that allow seamless TPP interaction with ASPSP's channels.

Dashboards are another key feature which uses a set of functionalities allowing the relevant party to manage their accounts, permissions, consents, fraud and incident reporting, and others. Dashboards include a ticketing system for easier communication between the TPP, Salt Edge and ASPSP.
